## Safety and Infrastructure Protection Crew Lead (SIPCL) Test

#### **OVERVIEW**

Pacific Gas and Electric Company believes it is critical that employees have the lead skills and abilities necessary to succeed in lead jobs across the company. The Safety and Infrastructure Protection Crew Lead (SIPCL) Test allows PG&E to make an initial assessment of your skills and abilities as related to lead occupations. Because the SIPCL is standardized, it ensures that everyone who wants to be considered for a lead position receives a fair and objective opportunity. This assessment has been professionally validated to ensure job-relatedness.

The SIPCL is an online, proctored assessment that contains 50 questions and takes 90 minutes. It measures the job knowledge areas listed below:

## **During the Test**

It is important that you follow the directions of the Test Administrator. If you have any questions about the testing session, be sure to ask before the testing begins.

Once you start the test, you may **NOT** leave the room, talk, smoke, eat, or drink (except for bottled water). Bathroom breaks are **not** allowed once you start the test. You should consider these factors before beginning the test.



All cellular devices, smart phones, smart watches, music players, earphones, personal calculators, cameras, or other electronic equipment will **NOT** be allowed in the testing area. Please secure these items **before** entering the testing location. Employees will need to complete LiveSafe prior to checking in and will secure their cell phones as they enter the testing room.
