Pre-requisites for OQ tasks

**Audience:** All gas employees and contractors possessing OQ tasks, their Supervisors,

### Why it matters to you?

This 5mm informs and provides clarification regarding pre-requisite requirements for GAS OQ's. This change will impact any OQ that has a pre-requisite OQ.

#### What you need to know?

#### These changes will go into effect Feb 27th, 2023.

- An employee or contractor will lose an OQ if you fail to qualify/re-qualify on applicable pre-requisite tasks. As an example, if you currently hold 0501 and 0502 and fail to regualify on 0501 then you will lose 0502 as well.
- Once you requalify on the pre-requisite OQ then the suspended dependent OQ will be re-instated. With above example, 0502 will be re-instated once you re-qualify on 0501.

The Guide to Qualification document lists all the OQ's that have pre-requisite requirements. These rules will be applied in ITS on Feb 27th and will have the following impact:

#### **Key discussion points**

#### What has changed with the OQ's?

- **Guide to Qualification** has the updated pre-requisite requirements for GAS OQ.
- The **rules for pre-requisites** will be enforced in ITS for employees and contractors on Feb 27<sup>th</sup>, 2023.
- Employee and Contractors will see OQ's getting dropped and re-instated depending on the status of testing for pre-requisite OQ's.
- A new pre-requisite requirement has been added to Guide to Qualification for OQ-0612. OQ-0601 is now required to be held to qualify for OQ-0612.

#### FAQs:

- > Question: Will this impact my current qualification if the pre-requisite conditions are not met?
- ✓ <u>Answer</u>: We will provide a grace till end of June 2023 to ensure current pre-requisite status for existing qualification
- Question: Can I see the pre-requisite information in self scheduling tool that is used for scheduling OQ's for employees?
- ✓ <u>Answer</u>: Yes. You can see them all except 0321 and 0323. 0321 and 0323 required external certification that does not exist in SAP yet. It's only maintained in ITS.
- **Question**: Will I be notified if an employee fails to requalify on pre-requisite task and the system suspends the dependent OQ?
- ✓ Answer: PG&E supervisors will be notified. It will be reflected in OQ card as well.
- Question: Will I be notified once the suspended OQ is reinstated after qualifying for pre-requisite task?
- ✓ Answer: PG&E supervisors will be notified. It will be reflected in OQ card as well.
