### Time-of-Use

Time-of-Use rate plans can help you save money based on when your business uses energy. Prices are higher during peak hours and lower at all other times.

Peak hours for business customers are 4–9 p.m. Log in to your online account to see how your bill will be affected.

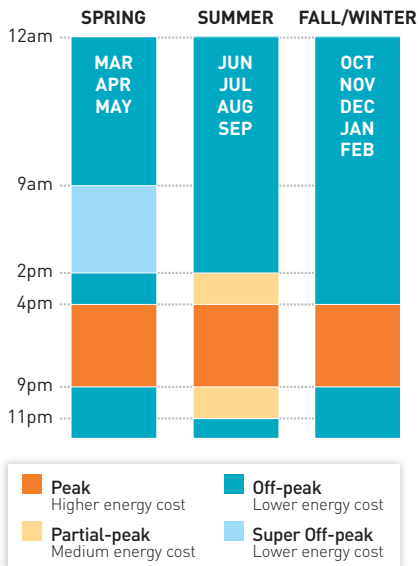
**Business Low Use (B1)** is for small businesses with low energy use, whose demand is less than 75 kW.

**Business Low Use Alternative (B6)** is for small businesses with low energy use, whose demand is less than 75 kW and who have some flexibility to adjust their energy use throughout the day.

**Business Medium Use (B10)** is for medium businesses with moderate energy demand consistently under 500 kW and includes a Demand Charge per kW based on maximum load.

**Business Medium-High Use (B19)\*** is for large and medium businesses with moderate to high energy demand consistently under 500 kW. This rate features lower energy rates but a higher Demand Charge than the B10 Rate Plan.

\*Customers with energy use over 499 kW and over 999 kW for three consecutive months will automatically transition to B19 and B20 TOU rates, respectively. To learn more, visit [pge.com/tariffs](http://pge.com/tariffs).



### Peak Day Pricing

Peak Day Pricing Event Hours are 5–8 p.m. Beginning **March 2022**, the hours will be 4–9 p.m. Peak Day Pricing combines a time-of-use rate with surcharges on 9 to 15 Event Days each year, plus credits on all summer usage.

## Clean Energy Alternatives

**Net Energy Metering** allows businesses to install a renewable generator, interconnect to the PG&E grid and receive credits to offset the cost of their energy usage. With certain additional requirements, storage can also be installed with the renewable generation. To learn more, visit [pge.com/savewithrenewables](http://pge.com/savewithrenewables).

**Option R** is available for qualifying E19, E20, B19 and B20 customers with solar generators that provide 15% or more of their annual electricity usage. Subject to program caps.

**Option S** is available for qualifying B19 and B20 customers with storage that has rated capacity in watts of at least 10% of peak demand over the previous 12 months. Subject to program caps.

**Business Electric Vehicle Rate (BEV)** allows customers more affordable charging, simpler pricing structures, and improved budget certainty.

**B1 Storage Rate Option (B1-ST)** is available for small business customers with eligible storage capacity.

**Note:** Direct Access and Community Choice Aggregation customers purchase electricity from another provider and receive electric transmission and distribution services from PG&E. These customers are eligible for many, but not all, of the rate plans or features listed in this notice. To learn more, contact your provider.

## Natural Gas Rate Plans

Your rate plan is determined by the level of service you need and the amount of gas used per month. For details and more information on all gas rates, visit [pge.com/tariffs](https://www.pge.com/tariffs).

**Small Commercial (G-NR1)** is for businesses with average monthly use less than 20,800 therms for the last 12 months in which gas use exceeded 200 therms.

**Large Commercial (G-NR2)** is for businesses with average monthly use greater than 20,800 therms for the last 12 months in which gas use exceeded 200 therms.

For both gas rates, you may choose who supplies your natural gas—PG&E or a third party gas supplier. We will continue to deliver gas to your business regardless of which supplier you choose. Both rates are also available to separately metered common areas in a multifamily complex.

## Rates for Natural Gas Vehicles

### Refueling Stations for Natural Gas Vehicles (G-NGV1)

applies to the sale of uncompressed natural gas for the sole purpose of compressing it for use as a motor vehicle fuel while **G-NGV2** provides compressed service at our stations open to the public.

**G-NGV4** is for natural gas fueling stations that have elected noncore service and maintain an average monthly use greater than 20,800 therms for the last 12 months, through a single meter, excluding the months that do not exceed 200 therms.
