### CUSTOMER AUTHORIZATION FOR CORE GAS AGGREGATION SERVICE

I authorize the Core Transport Agent (CTA) listed below to act on my behalf and provide natural gas service under Pacific Gas & Electric's (PG&E's) tariffs for Core Gas Aggregation Service provided to me in accordance with the rules and regulations of the California Public Utilities Commission (CPUC). I understand that PG&E shall continue to provide gas transportation services pursuant to its tariffs.

I also agree to and acknowledge that PG&E is authorized to release my current and historical gas usage and energy billing and payment information (Information) to my CTA. This Information includes any negotiated payment plans entered into between myself and PG&E, to my CTA as a condition of obtaining natural gas under PG&E's tariffs for Core Gas Aggregation Service<sup>2</sup>. I authorize PG&E to release the Information that is necessary to provide Core Gas Aggregation Service for the PG&E account(s) (identified by PG&E Gas Service Agreement Number) set forth in this Authorization to my CTA. I understand that this Information will assist PG&E and my CTA in providing better customer service. My CTA is required by the CPUC, and has agreed, to keep this Information secure and confidential at all times.

Under Core Gas Aggregation Service provided by the CTA, I will continue to be responsible for payment of PG&E's gas transportation charges, even if I authorize PG&E to send information about my gas transportation charges to my CTA. I understand and agree that the CPUC will continue to regulate PG&E. I also understand that the CPUC does not regulate my CTA's pricing under Core Gas Aggregation Service and that I am responsible for any agreement with my CTA for such pricing and service. I understand and agree that CTA's are not agents of PG&E, and PG&E shall not be liable for any of the Core Transport Agent's acts, omissions or representations including any liability resulting from use of information disclosed to my CTA or others as part of this authorization.
