- Defective Parts Per Million (DPPM) result that was 18% below target resulting in 99.97% defect-free materials;
- Five Suppliers who earned PG&E's SQA Quality Award, achieving the vision of zero non-conformances for an entire year;
- 91% of our high-risk material suppliers have been confirmed as ISO 9001 certified.

- Root Cause & Corrective Actions to prevent reoccurrences of quality issues;
- Notification of any manufacturing changes or recalls through the electronic Supplier Change Request (eSCR) portal;
- Direct upload of **Material Test Reports (MTR)** / Certifications through our <u>submission portal</u> for all gas materials subject to Federal Traceability requirements;
- Providing material from PG&E qualified manufacturing plants / locations per the PG&E Qualified Supplier List (QSL);
- Open and **timely communication** regarding quality issues and concerns that may arise with our Supplier Quality Engineers, Inspectors and Auditors.

SQA Quality Performance Award

We are revamping the Quality Performance awards this year and will re-launch the awards in 2025.

We initiated the SQA annual award over seven years ago and have had the honor of recognizing many of our suppliers for outstanding quality performance. We will continue that tradition, however, will take the opportunity to make some changes this year and will relaunch in 2025. More details to come!
